CEO Alex Meade said that Mission EDC would like to spearhead a new program similar to Code the Town, but with a focus on engineering. He said that Royal Technologies Corporation had inquired about an engineering training program for kinder to 12 grade kids and had expressed interest in matching the \$30,000 MEDC contributes, if approved. Mr. Meade said that in reaching out to Sylvan Learning Center, they have also agreed to match the MEDC's \$30,000 contribution and partner with Royal Technologies and Mission EDC for the creation of such program. The program will be called "Enginuity". If approved next month, he plans on promoting the program at schools in the Mission area.

There being no further comments, President S. David Deanda Jr. declared the public hearing closed at 5:46 p.m. p.m.

The notice of public hearing and notice of intention to undertake the project was published on April 24, 2015 and the 60 day comment period will end on June 23, 2015.
