He stated that some of the technology had to be returned for replacement. He said almost half of the offices have been leased and the building has been used significantly by the City of Mission, U.S. Border Patrol, Regional One, Teach for America and Mission CISD, averaging about 150 people every other day. There are different price rates for rental of the classrooms, lecture hall, or other areas of the building. Rates vary depending on who wants to rent. There is a special rate for partners in the building, and a rate for non-profits as well as for-profit businesses. Current tenants are BBVA Compass Bank, People Fund, Teach for America, Shreiner University, Code RGV, Cruz Control, and Foldio, a 3-D printing company; and RGVision, are all leasing from us.
