Mr. Meade mentioned that the buyer for this property had actually added half acre to the property on Item 5 in case he needed to expand. The buyer, Jorge Francisco Rios, plans on constructing a cold storage facility for lease.

Councilman Ruben D. Plata moved to authorize the CEO to sell 2.537 Acres out of Lot 5A, Replat of Lots 5A and 11A, Expressway Business Park Phase VIII, Instrument 2788970, Hidalgo County Map Records (H.C.M.R.), City of Mission, Hidalgo County, Texas, to Jorge Francisco Rios, for the sales price of \$331,535.00 payable in full at closing, and to further authorize the CEO to execute whatever documents and pay whatever costs are deemed
