Mr. Meade mentioned that one of the conditions that MEDA placed every time they sold a property was that if the buyer didn't comply with what they promised to do with the property MEDA had the option to purchase the property back from the buyer. In 2006 MEDA sold a property to Robert de la Cruz located in the Expressway Business Park Phase XI, Lot 3. Mr. De La Cruz complied with MEDA's requirement of building a small warehouse; however, the building has been vacant for a few years. Mr. De La Cruz found an investor who owns a company called Butler Weldments, a steel fabrication and machining company, who wants to purchase the building, but since the condition continues to be in the Special Warranty Deed, he has been unable to sell it. Mr. Meade reminded the Board that MEDA's goal is not to acquire any more land but to sell the surplus land. He is requesting that the Board waive the conditions and restrictions. Brief discussion took place.

After the discussion, Councilman Ruben D. Plata moved for approval to authorize CEO to Terminate and Waive Conditions, Restrictions and Option to repurchase, all regarding Lot 3, Expressway Business Park, Phase XI, an addition to the City of Mission, Hidalgo County, Texas as per map or plat thereof, Recorded in Volume 41, Page 57, Map Records of Hidalgo County, Texas, as described in deed recorded as instrument number 2006-1641906, Official Records of Hidalgo County, Texas. The motion was seconded by Jody Tittle approved 5-0.
