

ALL RETAILERS & BUSINESSES



- Regularly sanitize frequently touched surfaces such as doorknobs, seats, tables, chairs, counter tops, registers, restrooms, etc.
- ALL non-essential retailers may operate with only 25% of total listed capacity.
- Retailers are encouraged to designate a specific time of the day for at-risk customers.
- Monitor what items and surfaces customers frequently touch, when customers leave, disinfect and sanitize those areas and items.
- Contactless payment is encouraged, where not available, contact should be minimized.
- If possible, make sanitizer, disinfecting wipes, soap and water, or similar disinfectants readily available for customers and employees.



ALL Employees & Citizens

- Individuals should stay informed and take precautions based on common sense and wise judgment that will protect health and support economic revitalization.
- Train all employees and volunteers on appropriate hygiene, and respiratory etiquette in the workplace.
- Screen employees and volunteers before coming into work and send home anyone that is sick.
- Have all employees sanitize their hands upon entering and between interactions with customers.
- Maintain 6 ft distance from other people, other measures such as face coverings and frequent hand washing should be rigorously practiced.
- Have staff regularly disinfect items and surfaces after customers have left the area or establishment.






RESTAURANTS

- Operate at only 25% seating capacity
- Parties must maintain at least 6 ft distance from other parties at all times, including while waiting to be seated in the restaurant.
- No tables of more than 6 people, use disposable menus.
- Clean and disinfect the area used for dining after each group of customers depart, including the disinfecting of tables, chairs, stalls, and countertops.
- Do not leave condiments, silverware, flatware, glassware or other traditional table top items on an unoccupied table.
- Provide condiments only upon request and in single use (non-reusable) portions.
- If a buffet is offered, have restaurant employees serve the food to the customers.

Movie Theaters


- Operate at only 25% seating capacity
- Utilize remote ticketing options to help manage capacity limitations.
- Ensure proper spacing between parties,
 2 seats apart or 6 ft distance, unless they
 are from the same household or are
 attending as one party.
- Alternate rows between customers (every other row left empty.)
- Disinfect between movie screenings.
- Clean and disinfect the area used for dining after each group of customers depart, including the disinfecting of tables, chairs, stalls, and countertops.





Churches

- Strongly encourage at-risk population to participate remotely. Otherwise, you may offer a separate service or reserve a designated area for those at-risk.
- Keep at least 2 empty seats or 6 feet between participants unless they are from the same household.
- Alternate rows between attendees (every other row left empty.)
- The same minimum standard health protocols apply to funeral homes, burials and memorials.




Museums & Libraries

- Operate at only 25% capacity
- Have employees and visitors
 maintain at least 6 feet separation
 from others. If such distancing is
 not feasible, measures such as face
 coverings, hand hygiene, cough
 etiquette, cleanliness, and
 sanitation should be rigorously
 practiced.
- Regularly clean and disinfect any frequently touched surfaces, such as doorknobs, tables, chairs, and restrooms.
- Make hand sanitizer, disinfecting wipes, soap and water, or similar disinfectants readily available to employees and visitors.
- Any interactive exhibits must remain closed.

Outdoor Sports

- No more than four participants may play the sport at any time and the sport may not include contact at any time.
- Self-screen before playing in any outdoor sport for any new or worsening signs of possible COVID-19.
- Special consideration for golf courses:
 - Clean and sanitize golf carts and pull carts between uses.
 - Clean and disinfect driving range golf balls between use.
 - Ensure separation of at least 6 feet between golfers on the driving range.



Miscellaneous

- Continue to use strict social distancing, stay home as much as you can, wash hands often, cover your cough and face coverings are strongly recommended
- Within shopping malls, the foodcourt dining areas, play areas, and interactive displays and settings must remain closed.
- Nursing homes, state supported living centers, assisted living facilities, and long-term care facilities must remain closed to visitors unless to provide critical assistance.
