Due to financial market conditions, the Series 2020A bonds were issued for an initial short term with the intent of remarketing the bonds when the financial markets stabilized and the company was ready to proceed with issuing their Series 2020B (refunding) bonds in the amount of \$52,000,000. order to align the remarketing date of the Series 2020A bonds with the of Series 2020B bonds scheduled to be issued on July 31, 2020, the Series 2020A Indenture must be amended and supplemented to provide additional flexibility on timing. Amending and supplementing the indenture requires approval by the MEDC Board and the bondholder, which is currently Waste Management, Inc. He is recommending approval of the resolution.
