1. Call to order

With a quorum being present Vice President Pete Jaramillo called the meeting to order at 6:12 p.m.

2. Approval of Minutes: Special meeting of October 27, 2021

There being no corrections or additions Secretary Aissa I. Garza moved for approval of the special Board meeting minutes of October 27, 2021. Motion was seconded by Mario Garza and approved 4-0.

3. Approval of Unadjusted and Unaudited Financial Statement for September 2021

Finance Director Angie Vela presented and recommended approval of the Unadjusted and Unaudited Financial Statement for September 2021. She mentioned that the year has not closed yet, but that everything is posted, and that staff is reviewing entries to make sure nothing needs to be reclassified. Ms. Vela said there are a few expenditures that have not been posted due to timing constraints, but they are minimal. The only entry that may be significant is related to the EDA \$3 million grant. Ms. Vela is inquiring with the auditors to see if at the end of year, a remaining amount of \$225,000 is something that needs to be reclassified.

Secretary Aissa I. Garza noted an error on the financial statement. An amount on Page 8, Long Term Debt is incorrect. The Debt Retirement balance should be \$11,670,359.90 instead of \$14,074,258.88. She also inquired about MEDC's net position and a surplus amount of \$436,000 on Economic Development. Ms. Vela said that last year, MEDC's net position was \$277,706. This year it is \$1.2

million. On the surplus amount, Ms. Vela said that \$125,000 was related to an incentive that has not been expensed but that it will be paid out during the new fiscal year. The remaining amount is related to MEDC programs that were placed on hold due to COVID.

Subject to a correction made by Secretary Aissa I. Garza on the amount on the Debt Retirement service from \$14,074,258 to \$11,670,359.90, Mayor Armando O'Caña made a motion to approve the Unadjusted and Unaudited Financial Statement for September 2021. Motion was seconded by Mario Garza and approved 4-0.

4. Acceptance of Quarterly Report of Investments for the Quarter ending September 30, 2021, and Interest Earned for Twelve Months ending September 30, 2021

Finance Director Angie Vela presented the Quarterly Report of Investments for the Quarter ending September 30, 2021, and Interest Earned for Twelve Months ending September 30, 2021.

There being no corrections or additions, Secretary Aissa I. Garza made a motion to accept the Quarterly Report of Investments for the Quarter ending September 30, 2021, and Interest Earned for Twelve Months ending September 30, 2021. Motion was seconded by Mario Garza and approved 4-0.
