Upon gathering all required documents, email to mypet@missiontexas.us or walk-in delivery to <u>117 E.</u> <u>Tom Landry Street, Mission, TX 78572</u> (ATTN: Grants Department). Staff will only review complete applications for eligibility and continue with the award process in the order received.

Applications for assistance will be processed on a first come, first served basis until all grant funds are exhausted.

Lease Agreement Statement showing the amount of pet deposit. (PHOTOCOPY)
Past 30 days most recent pay stubs for each applicable household member. [Verification of any other form of income.] <i>(PHOTOCOPY)</i>
Water Utility Bill (If Applicable) <b>(PHOTOCOPY)</b>
Complete Application Forms (2 pages)
Animal Vaccine Record (If Applicable) (PHOTOCOPY)
