### **EXECUTIVE SUMMARY**

On October 2021, the Mission Police Department became a National Incident Based Reporting System (NIBRS) reporting agency. Annual Crime Report, reflects on NIBRS data compiled. Data included in this report is as follows;

- Crime Trends and Analysis
- Summary of Offenses
- Victimology
- Offenders
- Victim/Offender Relationships
- Arrest Data

The Mission Police Department is presenting our first Annual Crime Report. This report consists a variety of data compiled from multiple Bureaus from our department. All crime data is submitted monthly to The Texas Department of Public Safety. NIBRS data is also included in the State of Texas Crime Book.

The Mission Police Department reported a total of 3,563 offenses for 2023. During 2023, the Mission Police Department reported an overall decrease of **23.10%** when compared to 2022. Crimes Against Persons reported a decrease of 8.50%, Crimes Against Property a decrease of 36.36% and Crimes Against Society a decrease of 10.56%. Crime rate decreased by **23.99%**.

The Mission Police Department continues to use our statistical data to identify patterns and trends within our City and is essential in developing, implementing and assessing evidence based policing strategies.

Moreover, I want to thank our City Council, City Mayor, City Manager and members of our department and community for their continued support and dedication to make our City of Mission a safer place to live.

#### INTRODUCTION TO NIBRS

Chief of Police

#### **HISTORY**

Since its inception in 1930, the Uniform Crime Reporting program has presented Summary-based totals for the main Index Crimes (i.e., murder, rape, robbery, aggravated assault, burglary, motor vehicle theft, and larcenytheft). Arson and human trafficking were added to this list more recently. While the program has shifted to the more-detailed NIBRS reporting methodology, summarized totals are still used for several reasons: (1) ease of comparison to historical data and the FBI's Crime Data Explorer (CDE), (2) to allow a consistent representation of crime data across the states, as nationwide adoption of NIBRS reporting data is still relatively low, and (3) provide a quick view of Crimes Against Persons and Property. 1

The Texas UCR Program serves as the state repository for the collection of crime statistics. The Program's primary objective is to generate reliable information for law enforcement administration, operation, and management. As the Program has evolved and the demand for transparency has increased, so has the demand for the data compiled under this Program. Policy makers and members of the public, including the media and academia, rely upon this data for information on the fluctuations in the level of crime from year to year in their communities and throughout the state.

The Department makes every effort to ensure accuracy in reporting by providing training and quality control checks on the data to confirm the validity of the data it receives from the more than 1,000 agencies contributing to the Program. The accuracy of the statistics depends primarily on each contributor's adherence to established reporting standards; therefore, it is the responsibility of each contributor to submit accurate data and subsequently correct any data submitted in error. It is important to note that participation in the program by law enforcement agencies is voluntary.

#### Reporting is Now Mandated by Texas Legislature

The 88th Regular Legislative Session (2023) passed HB 4879, amending Sec. 411.054 of the Texas Government Code. The legislation now mandates local law enforcement agencies to implement an incident-based reporting system and use it to report data and statistics to the UCR program. These measures aim to improve the timeliness of reporting and enhance the accuracy of incident-based data. TXDPS will promulgate rules specifying the methods, form, and submission timelines for incident-based data. 2

The Mission Police Department Participates in the FBI National Incident Based Reporting System since 2021.

#### DATA ANALYSIS-CRIME STRATEGIC OPERATIONS

Promoting effectiveness and efficiency of analytical data, high visible police presence is a core operational element for reducing crime. Our agency reviews data for crime hot spots, crime prevention, public information and community engagement to complement our agency activity. Our use of personnel time, accurate and complete report writing, visuals such as hotspots to show current areas where our manpower is needed the most. The Mission Police Department Crime Analysts collects and disseminates data regarding all reports and documentation also help implement our daily strategical operations necessary to combat crime.

The following are operations used to help enhance effectiveness of our department;

Data Collection
Data Analysis
Strategic Operations
Monitoring, Evaluation, and Adjustments

High visibility is a traffic and safety approach designed to create deterrence and change unlawful behaviors. Our department efforts are intended to be high profile interactions, building the perception of police presence, to educate the public and promote voluntary compliance with the law.

The Mission Police Department utilizes mapping software's to assist in location-based tracking of an event or incident, most often using computerized geographic information system (G.I.S.). Through this software we are able to get Hotspots, Hotspots are a geographical area that is distinguishing concentration of events or activities.

The Mission Police Department has and will continue to strengthen with use of innovative strategic operations.









#### **CRIME STRATEGIC OPERATIONS**

#### **Identifying Strategies and Tactics**

Crashes, crime and traffic safety issues identified through the analysis will dictate the deployment of strategies and tactics. The Mission Police Department focuses on identified problems which help crime reductions and better help serve our community directly through actionable analysis by applying resources in the right places and at the right times.

Currently our department utilizes data collection, data analysis and the implementation of innovative technology such as skywatches, drones and license plate readers, motorcycle patrol, high visibility units.

Implementing strategic operations will continue to help our Department better serve our Community.














## CHAPTER 2 GROUP A OFFENSE

#### **GROUP A OFFENSE SUMMARY**

There are 28 Group A crime categories made up of 71 Group A offenses; therefore, there are 71 Group A Offense Codes. Each NIBRS offense belongs in one of three categories: Crimes Against Persons, Crimes Against Property, and Crimes Against Society. Crimes Against Persons, e.g., Murder, Rape, and Assault, are those offenses whose victims are always individuals. The object of Crimes Against Property, e.g., Robbery, Bribery, and Burglary, is to obtain money, property, or some other benefit. Crimes Against Society, e.g., Animal Cruelty, Drug Violations, Gambling, and Prostitution, represent society's prohibition against engaging in certain types of activity.



#### SUMMARY OF REPORTING YEAR

#### **Crimes against Persons**


- During the reporting year, there were a total of 1,313 Crimes Against Persons.
- Crimes Against Persons decreased by 8.50 % when compared to previous year.
- Crimes Against Persons accounted for 37% of all offenses reported.
- Crimes Against Persons rate decreased by 9.02% when compared to previous reporting year.

#### **Crimes against Property**

- Crimes Against Property reported a total of 1,505 offenses.
- Crimes Against Property accounted for 42% of all offenses.
- During 2023 Crimes Against Property decreased by 36.36% when compared to previous year.
- Crimes Against Property rate decreased by 36.72% when compared to previous reporting year.

#### **Crimes Against Society**

- Crimes Against Society reported a total of 745 offenses for the year.
- During the reporting year Crimes Against Society reported a decrease of 10.56% when compared to previous reporting year.
- Crimes Against Society accounted for 21% on category.
- Crimes Against Society rate decreased by 13.96% when compared to the previous reporting year.



#### **CRIMES AGAINST PERSONS**

#### HOMICIDE OFFENSES

Homicide offenses are defined as the "killing of one human being by another". The offenses reported under the category of Homicide are Murder and Non-Negligent Manslaughter, Negligent Manslaughter, and Justifiable Homicide.

#### Murder

The willful (nonnegligent) killing of one human being by another. As a general rule, agencies should classify in this category any death due to injuries received in a fight, argument, quarrel, assault, or commission of a crime. Although law enforcement agencies may charge offenders with lesser offenses, e.g., negligent manslaughter, agencies should report the offense as murder and nonnegligent manslaughter if the killing was willful or intentional.




- There was 1 Murder for 2023.
- The Murder volume was 1.
- Offense rate was 1.16 for 2023.
- Crime occurred on a residence.
- Type of weapon used was a handgun.
- Circumstance was due to an argument.
- Victim age and gender was a 40-year-old female.
- Offender's age and gender was a 24-year-old male.
- Crime Occurred in the month of August 2023.
- Victim /Offender relationship was known to be an ex-boyfriend.

#### SEX OFFENSES

Any sexual act directed against another person, without the consent of the victim, including instances where the victim is incapable of giving consent

Definition Rape is defined in the national UCR program as "penetration, no matter how slight, of the vagina or anus with any body part or object, or oral penetration by a sex organ of another person, without the consent of the victim." The nature of Rape breaks down the total number of Rape into completed and attempted offenses. Statistics reported in this crime category include assaults to commit Rape; however, statutory Rape is excluded.



#### RAPE

The carnal knowledge of a person, without the consent of the victim, including instances where the victim is unable to give consent because of his/her age or because of his/her temporary or permanent mental or physical incapacity. Black's Law Dictionary, 6th ed., defines carnal knowledge as "the act of a man having sexual bodily connections with a woman; sexual intercourse." There is carnal knowledge if there is the slightest penetration of the sexual organ of the female (vagina) by the sexual organ of the male.


Statutory rape and incest are excluded from this category and are listed under the category of Sex Offenses, Non-Forcible.



- The Mission Police Department reported a total of 53 Sex Offenses for 2023.
- There were 19 Rapes committed in the reporting year.
- Rape reported a decrease of 67.80% when compared to previous reporting year.
- Sodomy reported a total of 8 offenses for the reporting year.
- Sodomy reported a decrease of 27.27% when compared to the previous year.
- Sexual Assault with Object Offense decreased 100% when compared to the previous year.
- Fondling Offense reported an increase of 13.04% when compared to the previous year.
- The overall Sex Offense category decreased by 46.36% when compared to the previous reporting year.

#### RAPE



- The month of March reported a total of 4 offenses.
- June had no offenses reported.
- In 2023, 74% of the Rapes occurred in a Residence/Home type location.
- Out of the 3 people arrested for Rape 2 were male and one female.





#### ASSAULTS OFFENSES

An unlawful attack by one person upon another. The Assault offenses are recorded in three categories: Aggravated Assault, Simple Assaults, and Intimidation. The weapons used or the extent of the injury sustained typically will be the deciding factors in distinguishing Aggravated from Simple Assault. A weapon can be a gun, knife or anything that could be used to harm someone else (a broken glass bottle, rocks, a shoe, etc.) In only a very limited number of instances should it be necessary to examine the intent and capability of the assailant.



#### ASSAULT OFFENSES

Assault offenses are defined as unlawful attacks against one person upon another. The Assault offenses are recorded in three categories; Aggravated Assaults, Simple Assaults, and Intimidation. There are no attempted assaults, only completed assaults. The use or extent of weapon or the extent of the injury sustained will be the deciding factors in distinguishing the category of the assault offense.



#### AGGRAVATED ASSAULT OFFENSES


An unlawful attack by one person upon another wherein the offender uses a dangerous weapon or displays it in a threatening manner or the victim suffers obvious severe or aggravated bodily injury, or where there was a risk for serious injury/intent to seriously injure.

- Aggravated Assaults reported 135 offenses for the reporting year.
- The month of September reported 20 offenses.
- The month of July reported 5 offenses.




#### ASSAULT OFFENSES WEAPONS USED

The weapons used or the extent of the injury sustained typically will be the deciding factors in distinguishing Aggravated from Simple Assault. A weapon can be a gun, knife or anything that could be used to harm someone else (a broken glass bottle, rocks, a shoe, etc.) In only a very limited number of instances should it be necessary to examine the intent and capability of the assailant.




- Out of the 1,254 Assault offenses, other dangerous weapons accounted for 42% of the type of weapon used.
- Firearm and Knife/Cutting instrument accounted for 19%.


#### ROBBERY

The taking of anything of value from the control, custody, or care of another person by force or threat of force and/or by putting the victim in fear of immediate harm. Robbery involves the offender taking or attempting to take something of value from a victim, usually the property owner or custodian, by the use of force or threat of force.




#### BURGLARY OFFENSE CATEGORY



By definition, a structure has four walls, a roof, and a door (e.g., apartment, barn, cabin, church, condominium, dwelling house, factory, garage, house trailer or houseboat if used as a permanent dwelling, mill, office, outbuilding, public building, railroad car, room, school, stable, vessel or ship, warehouse). A structure is also any house trailer or other mobile unit permanently fixed as an office, residence, or storehouse. However, a tent, tent trailer, motorhome, house trailer, or any other mobile unit used for recreational purposes is not a structure.




- There were 103 Burglary offenses reported for reporting year.

- All Other Larceny




A motor vehicle is a self-propelled vehicle that runs on the surface of land and not on rails that is not proceeds of another crime and that fits one of the following descriptions:

- Automobiles—sedans, coupes, station wagons, convertibles, taxicabs, or other similar motor vehicles serving the primary purpose of transporting people This classification also includes minivans (which primarily transport people), automobiles used as taxis; sport-utility vehicles, such as Explorers, Highlanders, 4Runners, Pathfinders, and Hummers; and automobile derivative vehicles, such as Ranchero, El Camino, Caballero, and Brat.
- Buses—motor vehicles specifically designed (but not necessarily used) to transport groups of people on a commercial basis
- Recreational Vehicles—motor vehicles specifically designed (but not necessarily used) to transport people and provide them with temporary lodging for recreational purposes
- trucks—motor vehicles specifically designed (but not necessarily used) to transport cargo on a commercial basis Pickup trucks and pickup trucks with campers should be classified as 37 = Trucks, as they meet the definition specifically designed, but not necessarily used, to transport cargo.
- Other Motor Vehicles—other motorized vehicles, e.g., motorcycles, motor scooters, trail bikes, mopeds, snowmobiles, all-terrain vehicles, or golf carts whose primary purpose is to transport people.
- Motor Vehicle Theft reported 43 offenses for the reporting year.
- Motor Vehicle Theft decreased 63.87% when compared to the previous reporting year.
- The Motor Vehicle Theft rate was 49.67 for the reporting year.
- The month of July and November reported the highest Motor Vehicle Theft offenses with 6 offenses reported.



#### **FAMILY VIOLENCE**


The Texas Family Code, Chapter 71.004, defines Family Violence as "an act by a member of a family or household against another member of the family or household that is intended to result in physical harm, bodily injury, assault, or sexual assault or that is a threat that reasonably places the member in fear of imminent physical harm, bodily injury, assault, or sexual assault, but does not include defensive measures to protect oneself." The law includes abuse, defined as physical injury that results in substantial harm or genuine threat; sexual contact, intercourse, or conduct; or compelling or encouraging the child to engage in sexual conduct. The law excludes the reasonable discipline of a child. For Family Violence Reporting, the law defines "family" to include individuals related by consanguinity (blood) or affinity, marriage or former marriage, biological parents of the same child, foster children, foster parents, and members or former members of the same household (including roommates regardless of gender).\*\*



- During the reporting year, there were 733 Family
   Violence incidents reported.
- Of the 733 incidents reported, "Simple Assaults" accounted for 65% of all the offenses reported.
- Intimidation accounted for 21% of incidents reported during the reporting year.



#### **FAMILY VIOLENCE BY WEAPON USED**




- The most common weapon used during the Family Violence reported was the "Personal Weapons".







# CHAPTER 5 CALLS FOR SERVICE

#### **CALLS FOR SERVICE**


The Mission Police Department Communications Bureau is responsible for 24-hour staffing and answering all 911 calls for police service. Personnel are also responsible for answering non-emergency calls for service and public assistance calls. Public safety dispatchers are the vital communication link between the public and police officers. In addition to these duties, dispatchers process all information requests from police officers including driver's license queries, vehicle registration queries and warrant queries. They process confirmed warrants and enter missing persons, stolen/towed/impounded vehicles, stolen firearms, warrants and restraining orders into the appropriate law enforcement databases.

- During 2023, the Mission Police Department responded to 65, 238 calls for service.
- Calls decreased in comparison to the previous year by 4.61%.
- The month with the highest calls for service was December with a total of 5,954 calls.
