#### 3. Proclamation - National Night Out

#### **4.0** Approvals and Authorizations

# 4.1 Authorization to Execute Second One-Year Renewal Option with Conde's Landscaping and OCL Enterprises for Weedy Lot Abatement

In 2016, the City of Mission entered into a contractual agreement with Conde's Landscaping and OCL Enterprises for weedy lot abatement. The terms for this contract was for one year with two one-year renewal options. As per renewal letters, there would be no increase to the original proposal. Staff was seeking authorization to extend contract for second one-year renewal option with Conde's Landscaping & OCL Enterprises.

Staff and City Manager recommended approval.

Councilman O'cana moved to authorize to Execute Second One-Year Renewal Option with Conde's Landscaping and OCL Enterprises for Weedy Lot Abatement. Motion was seconded by Mayor Pro Tem Garza and approved 5-0

## 4.2 Authorize Mayor to execute a Reimbursement Agreement between Mission Redevelopment Authority, Reinvestment Zone Number One and City of Mission

Authorize Mayor to execute a Reimbursement Agreement between Mission Redevelopment Authority, Reinvestment Zone Number One and City of Mission in an amount not to exceed \$2,376,614. The reimbursement agreement was related to engineering and construction costs for a water tower to be located by the new events center in Mission.

The Board of Directors of the Mission Redevelopment Authority approved the reimbursement agreement at their June 29, 2017 meeting.

Staff and City Manager recommended approval.

Councilman O'cana moved to authorize Mayor to execute a Reimbursement Agreement between Mission Redevelopment Authority, Reinvestment Zone Number One and City of Mission. Motion was seconded by Mayor Pro Tem Garza and approved unanimously 5-0.

### 4.3 Acceptance of Quarterly Report of Investments for the Quarter ending June 30, 2017 and Interest Earned for Nine Months through June 30, 2017

Acceptance of quarterly report required by the Public Funds Investment Act Section 2256.023 of the Texas Government Code on the total investments for the quarter ending June 30, 2017. The total increases to investment balances for the period were \$391.73 and there was no decreases, leaving a total of \$1,299,794.45 in outstanding investments for the quarter ending June 30, 2017. The total interest earned on all funds year to date was \$10,990.12.

Staff and City Manager recommended approval.

Councilman O'cana moved to approve the Quarterly Report of Investments for the Quarter ending June 30, 2017 and Interest Earned for Nine Months through June 30, 2017. Motion was seconded by Councilwoman Jessica Ortega-Ochoa and approved unanimously 4-0.

#### 4.4 Tax Collection Report – June, 2017

Finance Director Angie Vela presented the Tax Collection Report – June, 2017 for approval.

Staff and City Manager recommended approval.

Mayor Pro Tem Garza moved to approve the Tax Collection Report – June, 2017. Motion was seconded by Councilman Plata and approved unanimously 5-0.

#### 4.5 June 2017 Financial Statements

Finance Director Vela presented the June, 2017 Financial Statements for approval.

Staff and City Manager recommended approval.

Councilwoman Ochoa moved to approve the June, 2017 Financial Statements, as presented. Motion was seconded by Councilman Plata and approved unanimously 5-0.

#### 4.6 Approval of Amendment to Interlocal Agreement with Hidalgo County

In February our annual Interlocal Agreement was approved by City Council. This Amendment cites the \$400,000 we would be receiving from Hidalgo County for the procurement of a digital library.

Staff and City Manager recommended approval.

Councilman O'cana moved to approve the Amendment to Interlocal Agreement with Hidalgo County. Motion was seconded by Councilwoman Ochoa and approved unanimously 5-0.

#### 4.7 Authorization to award bid for the purchase of Pest Control Services

On June 12, 2017, City Council authorized staff to solicit bids for Pest Control Services, which included labor, materials and equipment required for preventive pest control service for numerous city buildings. The City of Mission had accepted and opened six (6) bid responses. Staff recommended awarding bid to Pro-Tech Pest Control who was the lowest responsible bidder meeting all specifications in the amount of \$8,400.

Staff and City Manager recommended approval.

Mayor Pro Tem Garza moved to authorize to award bid for the purchase of Pest Control Services to Pro-Tech Pest Control, as recommended by staff. Motion was seconded by Councilwoman Ochoa and approved unanimously 5-0.

#### 4.8 Authorization to solicit Proposals for Professional Services for Irrigation Design

Staff was seeking authorization to solicit RFP's for Professional Services for Irrigation Design for Various City Parks currently without lawn irrigation.

Staff and City Manager recommended approval.

### 4.9 Authorization to solicit Bids for Fencing for New Dog Parks at Bannworth and Bentsen Palm Community Parks

Staff was seeking approval to solicit bids for the purchase and installation of a fence for the new Dog Park at Bannworth and Bentsen Palm Community Park.

Staff and City Manager recommended approval.

Councilwoman Ochoa moved to authorize to solicit bids for Fencing for New Dog Parks at Bannworth and Bentsen Palm Community Parks. Motion was seconded by Councilman O'cana and approved unanimously 5-0.

#### 4.10 Authorization to Award Contract for Palm Tree Trimming

City Council authorized staff to solicit bids for the Trimming of Palm Trees on and within City owned properties (Parks / City Facilities) on 06-12-17. The City of Mission received a total of three (3) bid responses from Rodz Lawn Care & Landscaping, Anna Leal and Raul Conde dba: Conde's Landscaping. Staff recommended awarding to Conde's Landscaping; the lowest responsible bidder meeting all specifications.

Staff and City Manager recommended approval.

Mayor Pro Tem Garza moved to authorize to Award Contract for Palm Tree Trimming to Conde's Landscaping, as recommended by staff. Motion was seconded by Councilwoman Ochoa and approved unanimously 5-0.

### 4.11 Authorization to reject and re-solicit bids for Boys and Girls Club Gym Athletic League Uniforms

City Council authorized staff to solicit bids for the purchase and delivery of Athletic League Uniforms for the Boys and Girls Club. The City of Mission had received and opened four (4) bid responses. Staff was seeking authorization to reject and re-solicit bids since (3) were found non-responsive for failure to submit bid bond as stated in the terms and conditions and the bid for MCM Sporting Goods, Inc. exceeded our budget, hence staff requested to reject and resolicit bids

Staff and City Manager recommended approval.

Councilman O'cana moved to authorize to reject and re-solicit bids for Boys and Girls Club Gym Athletic League Uniforms. Motion was seconded by Councilman Plata and approved unanimously 5-0.

# 4.12 Authorization to enter into an Interlocal Agreement between the Lower Rio Grande Valley Development Council and the City of Mission for the FY 2018-19 911 Public Safety Answering Point Services

The interlocal agreement outlines the duties and responsibilities of both the LRGVDC and the Mission Police Department in assuring the proper functioning of the city's 911system. The 911

System was in place in order to facilitate the response of emergency service providers to include the police department, the fire department and our local ambulance provider to the citizens of our community.

Staff and City Manager recommended approval.

Councilman O'cana moved to authorize to enter into an Interlocal Agreement between the Lower Rio Grande Valley Development Council and the City of Mission for the FY 2018-19 911 Public Safety Answering Point Services. Motion was seconded by Councilwoman Ochoa and approved unanimously 5-0.

#### 4.13 Presentation of the Preliminary Budget for the Fiscal Year 2017-2018

As per City Charter, the City Manager, between sixty (60) and ninety (90) days prior to the beginning of each fiscal year, shall submit to the City Council a proposed budget, in which the budget shall provide a complete financial plan for the fiscal year.

Staff and City Manager recommended approval.

Mayor Pro Tem Garza moved to approve the Presentation of the Preliminary Budget for the Fiscal Year 2017-2018. Motion was seconded by Councilwoman Ochoa and approved unanimously 5-0.

#### 4.14 Set Public Hearing date for FY 2017-18 Annual Budget

City Manager was requesting to set the Public Hearing on FY 2017-18 Annual Budget on Monday, August 28, 2017 as required by City Charter. Section 9.06. - Notice of public hearing on budget. At the meeting of the City Council at which the budget was submitted, the City Council shall fix the time and place of a public hearing on the budget and shall cause to be published in a newspaper of general circulation within the City of Mission, a notice of the hearing setting forth the time and place thereof at least ten (10) days before the date of such hearing. The public hearing was to give interested parties the opportunity to be heard. The public hearing date, time and location would be published in the local newspaper.

Staff and City Manager recommended approval.

Councilman Plata moved to approve to Set Public Hearing date for FY 2017-18 Annual Budget. Motion was seconded by Councilwoman Ochoa and approved unanimously 5-0.
