1. Call to order

At 5:38 p.m., Mayor Salinas stepped out of the meeting.

4.0 Approvals and Authorizations

4.1 Approval of Interlocal Agreement between City of Mission and Sharyland Independent School District to conduct joint elections in accordance with Texas Education Code Section 11.0581

The interlocal agreement was in accordance with Texas Education Code Section 11.0581 which stated that the voters of the joint election shall be served by a common place.

Staff and City Manager recommended approval.

Councilman Plata moved to approve the Interlocal Agreement between City of Mission and Sharyland Independent School District to conduct joint elections in accordance with Texas Education Code Section 11.0581. Motion was seconded by Councilwoman Ochoa and approved unanimously 4-0.

4.2 Authorization to Award Bid for Housing Assistance Program – Phase 17-I

On February 12, 2018 City Council authorized staff to solicit bids for reconstruction of six homes. The City of Mission had accepted and opened three (3) bid responses for these six (6) homes. Staff recommended to award projects to:

A One Insulation and G&G Contractors met all the Terms & Conditions and Specifications and came within budget. CAC met on March 6, 2018 and approved staff's recommendation for these homes.

The City had been utilizing 75% of the annual CDBG allocation for several years for housing projects. Since 1994, a total of 431 families to date had been provided some form of housing assistance. Out of the 431 families, 274 families received reconstruction assistance while 157 families received rehabilitation assistance (including CDBG-R, CDBG-DR and SSBG funds).

Staff and City Manager recommended approval.

Councilman Plata moved to authorize to award bid for Housing Assistance Program – Phase 17-I to A One Insulation and G&G Contractors, as recommended by staff. Motion was seconded by Councilman O'cana and approved unanimously 4-0.

4.3 Authorization to purchase Rifle Resistant Bulletproof Vests via a state approved contract (Buy Board Contract 507-16)

The City of Mission Police Department was requesting authorization to purchase a total of ninety-three (93) Rifle Resistant Bulletproof vests from Galls LLC Company, a state contract vendor. These rifle vests would be issued to our Patrol, SWAT, Bridge and Traffic Officers as an additional protection worn over their uniform in time of critical shooting situations. The vests would be purchased through a Grant Program at a cost of \$39,381.00. Staff was seeking a favorable recommendation.

Staff and City Manager recommended approval.

Councilman O'cana moved to authorize to purchase Rifle Resistant Bulletproof Vests via a state approved contract (Buy Board Contract 507-16) from Galls LLC Company, as recommended by staff. Motion was seconded by Councilman Plata and approved unanimously 4-0.

4.4 Authorization to purchase bulletproof vests via a state approved contract (Buy Board Contract 507-16)

The City of Mission Police Department was requesting authorization to purchase a total of thirty-six (36) bulletproof vests from Galls LLC Company, a state contract vendor. These vests would replace bulletproof vests currently in use by Mission Police Officers that were over five (5) years old. The vests would be purchased through our Bulletproof Vest Grant Program at a cost of \$28,764.00. Staff was seeking a favorable recommendation.

Staff and City Manager recommended approval.

Councilman O'cana moved to authorize to purchase bulletproof vests via a state approved contract (Buy Board Contract 507-16) from Galls LLC Company, as recommended by staff. Motion was seconded by Councilman Plata and approved unanimously 4-0.

At 5:43 p.m., Mayor Salinas rejoined the meeting.

4.5 Authorization to amend the Interlocal agreement between the Rio Grande Valley Communications Group and the City of Mission for the installation of P25 radio antenna system

The Mission Police Department was requesting authorization to amend the Interlocal Agreement with the Rio Grande Valley Communications Group for the placement of a P25 radio antenna at Military Highway and Bryan Road. The City of Mission was hereby requesting to change Section II. Duties of RGVGC, Subsection E for the purpose of allowing not only access to the tower site but strict authorization to service, repair or otherwise maintain any radio repeater and related appurtenances that were property of the City of Mission in case of system failure where the RGV Communications Group cannot respond to the emergency service call in a timely manner. The RGV Communications Group had agreed to the aforementioned change to the Interlocal Agreement.

Staff and City Manager recommended approval.

Mayor Pro Tem Garza moved to authorize to amend the Interlocal agreement between the Rio Grande Valley Communications Group and the City of Mission for the installation of P25 radio antenna system, as recommended by staff. Motion was seconded by Councilman Plata and approved unanimously 5-0.

4.6 Authorization to accept final completion of Mile 2 Roadway Project

On February 10, 2018, the Mile 2 Roadway Project from Conway Ave. to Moorefield Rd. was submitted to the City of Mission for final acceptance. On March 2, 2018, City staff and our Consultant L&G Engineering certified that the referenced project had been constructed in substantial compliance with plans and specifications.

Staff was seeking authorization to accept final completion of the Mile 2 Roadway project. Final acceptance would allow the City to receive final audit and approval from TXDOT.

City Manager recommended approval.

Mayor Pro Tem Garza moved to authorize to accept final completion of Mile 2 Roadway Project. Motion was seconded by Councilman Plata and approved unanimously 5-0.

4.7 Approval of Work Authorization No. 33 with L&G Engineering for the speed zone study at Mile 2 and Inspiration Rd

Work Authorization No. 33 entailed traffic engineering services for the speed zone study on two major corridors Mile 2 and Inspiration Rd.

Staff and City Manager recommended approval.

Councilman Plata moved to approve Work Authorization No. 33 with L&G Engineering for the speed zone study at Mile 2 and Inspiration Rd. Motion was seconded by Mayor Pro Tem Garza and approved unanimously 5-0.

4.8 Authorization to award bids to South Texas Pump for the removal of existing gas tanks

Staff was seeking authorization to award bid for the removal and disposal of existing gas tanks at the property located on SE corner of 6th Street and Conway. Staff received two (2) bids and was recommending award to South Texas Pump who was the lowest responsive and responsible bidder in the amount of \$6.750.

Staff and City Manager recommended approval.

Councilman Plata moved to authorize to award bids to South Texas Pump for the removal of existing gas tanks. Motion was seconded by Councilman O'cana and approved unanimously 5-0.

4.9 Authorization to Accept Donation from Winter Texan Activity Association

The Winter Texan Activity Association, an organized activities group had decided to cease activities after 30 years of operation. They played host to such fun activities that included bowling, billiards, golf and cabaret dancing that kept this vial group active and socializing during their stay in South Texas. Their Board by unanimous decision, voted to close their bank account and donate the remaining balance of \$1,364.72 to Mission Parks and Recreation Department.

Staff and City Manager recommended approval.

Councilman Plata moved to authorize to accept donation from Winter Texan Activity Association. Motion was seconded by Councilwoman Ochoa and approved unanimously 5-0.

4.10 Approval of Annual Hidalgo County Library System Interlocal Agreement

Hidalgo County was requesting approval of the annual interlocal agreement with them.

This agreement allowed the County to continue to pay funds on behalf of and disburse funds to Speer Memorial Library for contractual services and library materials.

Staff and City Manager recommended approval.

The Lieutenant was denied his presumptive statutory Worker's Compensation benefits by TMLIRP for his illness claim and was unable to return to work. As per Personnel Policy Manual number 600.09 "Upon denial of the firefighter's workers' compensation claim for an illness or injury for which a presumption exists, the governing body may consider placing the firefighter on temporary paid leave of absence during the period for which the firefighter is unable to return to work." The Lieutenant was currently pursuing a final determination of the workers' compensation claim.
