1. Call to order

With a quorum being present, Mayor Dr. Armando O'caña called the meeting to order at 4:34 p.m.

2. Approval of Resolution # 1573 in support of strengthening the Texas Trauma Network

Approximately 25% of Texans live in a county not accessible to a Level I trauma facility, and the nearest Level I Comprehensive Trauma Facility to Region V of the Texas Trauma Network is located over 240 miles away. The City of Mission believed that no Texan should ever go without timely access to the highest level of care when they needed it, therefore, the City of Mission hereby supported legislative efforts to make funding available to strengthen the Texas Trauma Network and ensured the residents of the Rio Grande Valley have timely access to the highest level of care when facing a severe traumatic incident.

Staff and City Manager recommend approval.

Councilman Ruben Plata moved to approve Resolution 1573 in support of strengthening the Texas Trauma Network. Motion was seconded by Councilwoman Jessica Ortega Ochoa and approved 4-0.

3. Authorization to accept the FY 2017 Staffing for Adequate Fire and Emergency Response (SAFER) Grant from the U.S. Department of Homeland Security

The Mission Fire Department had been awarded a \$1,022,828 grant to hire nine (9) firefighters. The goal of SAFER Grant was to assist local fire departments with staffing and deployment capabilities in order to respond to emergencies, and assure that communities have adequate protection from fire and fire-related hazards. The grant paid for the annual salary and benefits of the nine (9) firefighters. In the first two years the federal/city share was 75/25 or \$414,660/\$138,219; the third year was 35/65 or \$359,371/\$193,508; and in the fourth year 0/100.

Mayor Pro Tem Norie Gonzalez Garza joined the meeting at 4:38 p.m.

Staff and City Manager recommend approval.

Councilwoman Ochoa moved to accept the FY 2017 Staffing for Adequate Fire and Emergency Response (SAFER) Grant from the U.S. Department of Homeland Security. Motion was seconded by Councilman Plata and approved unanimously 5-0.

4. Ordinance # 4692 Adopting the Tax Rate

The Tax Rate for the fiscal year 2018-2019 was \$0.4862 per \$100 property value. In addition to establishing the tax rate, this ordinance provided a \$10,000 exemption for the elderly and a \$10,000 exemption for the disabled. The City also continued the tax freeze established in 2005 for the elderly and disabled, ensuring the total amount of ad valorem taxes paid would not increase.
