1. Call to order

With a quorum being present, Mayor Dr. Armando O'caña called the meeting to order at 5:30 p.m.

2. Discussion and action regarding the resignation of Councilman Gus Martinez, City Councilman Place 4

Councilman Gus Martinez had submitted his resignation of City Council Place 4.

Councilwoman Jessica Ortega Ochoa moved to accept the resignation of Councilman Gus Martinez, City Councilman Place 4 effective immediately. Motion was seconded by Councilman Ruben Plata and approved unanimously 4-0.

Councilman Gus Martinez will continue to serve as a holdover until his successor is qualified.

3. Discussion and possible action regarding appointment for City Council, Place 4.

Section 3.06. – Vacancies of the City of Mission Charter states:

When a vacancy occurs, in the City Council, the remaining members thereof must, within ten days, appoint a qualified person to fill the unexpired term of such vacancy; The unexpired term for Place 4 was May 2, 2020.

Councilman Plata recommended the appointment of Alberto Vela to take the position of City Council, Place 4 vacancy. Motion was seconded by Councilwoman Ochoa and approved unanimously 4-1. Councilman Gus Martinez abstained.

4. Approval of Resolution # <u>1599</u> of the City of Mission, Texas Establishing A Policy Guideline For Utility Fund Transfers To The General Fund

The following policy guidelines regarding operating transfers for administrative fees from the Utility Fund were hereby adopted:

The City should budget annually an Administrative Fee from the Utility Fund that represented payment for the services provided to the Utility Department and funded out of the City's General Fund. The Administrative Fee should be in an amount equal to 10% of the General Fund budget and should be paid out of Utility Fund revenue, excluding any funds received by the Utility Department from the Economically Distressed Areas Program. The Administrative Fee should be reported as a transfer out of the Utility Fund and as a transfer into the General Fund.

Staff and City Manager recommend approval.

Councilman Plata moved to approve Resolution # 1599 of the City of Mission, Texas Establishing A Policy Guideline For Utility Fund Transfers To The General Fund. Motion was seconded by Councilwoman Ochoa and approved unanimously 5-0.
