1. Call to order

Councilwoman Ortega asked the committee for their top three firms based on their evaluations.

Angie Vela, Finance ranked her top three firms as BKD, LLP, ABIP, PC and CRI, LLC.

David Flores, Deputy City Manager ranked his top three as BKD, LLP, CRI, LLC and ABIP, PC.

Ezeiza Garcia, Assistant Finance Director ranked her top two as BKD, LLP, and CRI, LLC.

Mayor Pro-Tem Garza was concerned with an acceptable rating that ABIP, PC. received in one area of the evaluation.

3. Authorize Staff to Engage Highest Qualified Firm found Acceptable in negotiations for Auditing Services and Authorize City Manager to execute contract incident thereto

Councilman Plata moved to authorize City Manager to negotiate and execute contract for Auditing Services with BML, motion died due to lack of a second.

Councilwoman Ochoa and Councilman Vela recommended BKD, LLP, as the first choice and CRI, LLC as the second choice if unable to negotiate with the first choice.

Councilman Plata recommended BML, LLP as the first choice and CRI, LLC as the second choice.

Mayor Pro Tem Garza recommended BKD, LLP, as the first choice, CRI, LLC as the second choice and BML, LLP as the third choice.

Councilwoman Ochoa moved to authorize City Manager to negotiate and execute contract with BKD as the first choice and CRI as the second choice and BML as the third choice. Motion was seconded by Mayor Pro Tem Garza and approved unanimously 5-0.

At 12:32 p.m. Mayor O'caña asked council to go into Executive Session.

Councilman Plata moved to convene into executive session pursuant to V.T.C.A. Gov. Code Sec. 551.001 for item 4 of the Agenda. Motion was seconded by Councilwoman Ochoa and approved unanimously 5-0.
