Dear Prospective Bidder:

The following is to be corrected/added/changed/clarified:

- a. This addendum is being provided to all bidders.
- **b.** Question: The specs call out for a flush girt condition, but the drawings indicate a bypass condition. Which are we to follow?

Answer: Bypass Condition.

c. Question: The bay spacing on the specs call out for four (4) at 20"-0 but the drawings show bay spacing of 19'-0 1/2", 2 at 20'-11 1/2", 19'-0 1/2:" Which do we follow?

Answer: Follow drawing bay spacing.

d. Question: What is the budget for this project?

Answer: \$90,000-\$110,000.

e. Question: What's going to be the material for the 16' road?

Answer: The City of Mission will construct the road.

f. Question: Will there be no flooring, just concrete finish?

Answer: Yes, only concrete finish.

g. Question: What's the material and size of wall for the office inside the warehouse? Metal Stud? 6" or 3 5/8" thick? Wall at 4 sides? Wall to deck? If not, what height?

Answer: Refer to "new" drawing detail.

h. Question: Do you want ceiling for the office? If so, what type of ceiling?

Answer: Refer to "new" drawing detail.

i. Question: Regarding building pad: Will there be a Geo Tech? How many inches about?

Answer: Remove at least 6" of top soil, natural ground, vegetation, debris, etc. from the proposed building area to a distance of five (5) feet outside the building line from the proposed. Build 18" above service road.

j. Question: Will there be a mini-split?

Answer: Yes

k. Question: Will you provide shop drawings?

Answer: Contractor shall provide two (2) copies of engineered shop drawings.

I. Question: Is American Steel required?

Answer: Yes

m. Question: What is the size of the office walls?

Answer: Nine (9) feet high

n. Question: Wood or metal studs?

Answer: Wood.

o. Question: Will it be dry wall/tape and float?

Answer: Yes

p. Question: Do you require warranty on the roof? How many years?

Answer: Yes. Twenty (20) years warranty.

q. Question: Do you require no leaks weather tightness?

Answer: Yes.

r. Question: What is the gauge?

Answer: Please refer to plans and specs.

s. Question: Wind low analyses?

Answer: Contractor to provide windstorm.

t. Question: Foundation footings?


Answer: Please refer to plans and specs.
