Texas Government Code TGC 418.108(a) provides that the presiding officer of the governing body of a political subdivision may declare a state of local disaster when City Council is not in session, subject to ratification by the City Council. Mayor O’cana proclaimed the existence of a local emergency within said in July 25, 2020 regarding Hurricane Hanna. Said local emergency shall be deemed to continue, and shall remain in effect and in full force until August 24, 2020, at 11:59 p.m. unless it is modified, amended, rescinded, or superseded.
