Traffic Study on the Mexican side will be starting from scratch. The factors to consider in the development of an international bridge project, including: feasibility study, advance planning development process, presidential permit application, environmental document preparation, agency coordination, alternative analysis and schedule. The goal of the team is to is to extend the existing permit which would require an amendment of the existing permit.
