1. Call to Order.

After establishing a quorum of the Board of Directors, Chairman S. David Deanda Jr., called the meeting to order at 1:40 p.m.

2. Approval of Minutes: January 19, 2021

Chairwoman Nora Longoria moved to approve the meeting minutes of January 19, 2021. Motion was seconded by Jose G. Vargas and approved 3-0.

3. Approval of Financial Statement ended December 31, 2020

Assistant Finance Director Ezeiza Garcia presented and recommended approval of the financial statement. She reported that beginning fund \$912,179; no Revenues were reported this quarter; Total Expenditures were \$5,043; and Ending Balance was \$907,527. Total Assets were \$1,192,284. Total Liabilities were \$284,757 and Total Fund Balance was \$907,527. Total Liabilities and Fund Balance was \$1,192,284.

There being no corrections or additions, Chairwoman Nora Longoria moved for approval. Motion was seconded by Jose G. Vargas and approved 3-0.

4. Sale of Sale of 5.87 Ac Melba Carter St., Mission, Texas 78572

CEO Daniel Silva said Pro Valley Foods, formerly H&H Foods of Weslaco, submitted a letter of intent for the purchase of a property owned by MEDA. The property is located off Mayberry and Melba Carter Street, Mission. Their offer was \$370,000 for the property. The client wants to build a meat market facility. Mr. Silva mentioned that there is an issue with an overhead power line that runs thru the property, but that issue will be addressed. He mentioned he has spoken to AEP about the issue, and they will do a power line adjustment which will involve relocating it to the south side of Melba Carter. There is a \$15,000 associated with this adjustment, which MEDA will have to take on. A question was made regarding the appraised value of the property. Mr. Silva said that the appraised value was \$500,000; however, in lieu of any incentive request, a discount on the property was offered. Chairman S. David Deanda Jr., said that since the property was offered at a discount, Pro Valley Foods should pick up the costs associated with the power line relocation. Treasurer Jose G. Vargas agreed with the Chairman.

Treasurer Jose G. Vargas moved to Authorize the CEO to sell 5.87 Ac Melba Carter St., Mission, Texas 78572 to Pro Valley Foods, as is without the power line relocation, for the sales price of \$370,000 payable in full at closing, and to further authorize the CEO to execute whatever documents and pay whatever costs are deemed necessary and reasonable by the CEO to consummate this transaction. Motion was seconded by Chairwoman Nora Longoria and approved 3-0.

5. Chairman Comments

Chairman S. David Deanda Jr. thanked everyone for participating.

The meeting was adjourned at 1:48 p.m.
