Job Summary:	Instructs children the correct way to play tennis and participate in tennis tournaments. Work involves daily contact with the public. Works under close supervision, with minimal latitude for the use of initiative and independent judgment.

Assisting in the organizing of tennis tournaments and out of town events with school districts, local Parks and Recreation Department, coaches, and organizations within the community.e. Enforces and follows facility and safety regulations.f. Communicates patron concerns and safety issues to management.g. Attends required meetings and trainings.h. Performs related work and reports as assigned.
