Job Summary:	Instructs children the correct way to play tennis and participate in tennis tournaments. Work involves daily contact with the public. Works under close supervision, with some latitude for the use of initiative and independent judgment.

Assists in the organization of tennis tournaments and out of town events with local Parks and Recreation Department, coaches and organizations within the community.e. Enforces and follows facility and safety regulations.f. Communicates patron concerns and safety issues to management.g. Attends required meetings and trainings.h. Performs related work and reports as assigned.
